Impact Latin America envisions God's peace planted in individuals, homes, and communities. So, we engage partners to equip Latin American leaders to foster a movement that multiplies disciples, leaders, and churches. IMPACT partners with 20 independent churches, 6 denominations, and 2 interdenominational pastors alliances. Through them, since 2020, 12,900 people have been equipped to share their faith through IMPACT's Disciples Making Disciples training. As a result, 14,682 people have come to Christ and 11,551 of these new believers (79%) are being disciplined in 1,493 active houses of peace. The number of active houses of peace increased 21% over 2023. Partners in Guatemala and the Dominican Republic reported their first network of houses of peace in 2024, bringing the total to 21 countries where IMPACT is working.
